2. The Institution shall be self-financing one without any commercialization or profit motive for which a separate Bank Account and Cash Book with related registers and money receipts should be maintained.
3. The Institute shall come up with building on its own land within stipulated time, if it does not have of its own.
4. The Institute shall not collect any donation from the students for the purpose.

5. The State Government shall not bear any financial liability at any point of time nor will the institution claim any sort of financial help on the ground of this permission from the State Government.
6. The Institution has to ensure adequate accommodation for Class room, Common room for the teachers and students, office room etc. in fire proof accommodation.
7. The Institution should adopt the course of studies as may be prescribed by Utkal University of Culture with adequate Library and Computer facilities.
8. The Institution shall abide by all norms and fulfil all terms and conditions of State Government and Utkal University of Culture prescribed from time to time to manage such Institution.
9. Any violation of Government norms will terminate this permission automatically.
